### **“ALL ACCESS PASSES TO THE EN AVANT DANCE TEACHERS CONFERENCE”**

#### **OFFICIAL RULES AND REGULATIONS**

1. No purchase necessary. To be eligible to win a prize in the “All Access Passes to the En Avant Dance Teachers Conference” contest (the “Contest”), a participant must be a legal resident of Canada, excluding the Province of Quebec, and must, at the commencement of the Contest Period be of the age of majority in his or her province of residence. Any potential participant who is an employee, representative and/or agent of Dance Media Group/Groupe Danse Média (“Sponsor”), its affiliated companies, advertising agencies, prize suppliers or other representatives or agents (the “Sponsor-related Parties”), or a member of the respective immediate families (which for the purpose of these rules shall be defined to mean parent, child, spouse or sibling) of such persons or anyone with whom such persons are domiciled is ineligible to participate in this Contest.
2. The Contest will run as follows: opening 12:00 a.m. Eastern Time (“ET”) on July 1, 2016 and closing at 11:59 p.m. ET on July 31, 2016 (this time period being the “Contest Period”).
3. Assuming a participant meets all of the eligibility criteria set out above, the participant can enter online at [www.thedancecurrent.com](http://www.thedancecurrent.com) (the “Site”) during the Contest Period by fully completing the entry form on the Site. Only one (1) entry into the Contest per person/per household/per email account will be accepted and eligible. Entries made with multiple addresses, under multiple identities, or through the use of any device or artifice to enter multiple times (in breach of these rules), or entries that are in excess of the permitted number of entries during the Contest period are automatically void. Contest entries obtained through unauthorized sources or that are incomplete, illegible, mutilated, altered, reproduced, forged, irregular or fraudulent in any way or otherwise not in compliance with these rules are automatically void. Sponsor may verify the validity of entries at any time in its discretion.
4. Draws for Prizes:  
  
A random draw from all eligible entries will be held at the offices of the Sponsor in Toronto, Ontario, on August 1, 2016 at 12:00 p.m. ET or as soon thereafter as is possible.  
  
The chances of being selected in the draw depend entirely upon the number of eligible entries received.

Selected participants will be notified by email to the participant’s e-mail address provided on the entry form, or by telephone at the number provided on the entry form, within seven (7) days of the draw and, prior to being declared a winner, will be required to correctly answer, unaided and without mechanical or electronic assistance, a time-limited, mathematical, skill-testing question.

If a selected participant is unable to correctly answer the skill-testing question, cannot be reached by e-mail or phone within forty-eight (48) hours of the draw, or otherwise does not meet all contest conditions and/or fully comply with these Contest rules, his or her prize will be forfeited and another entrant will be drawn from the remaining eligible entries.
7. There is one (1) prize (the "Prize") available to be won in this Contest, being two All Access passes to the En Avant Dance Teachers conference, with a total approximate retail value of CDN \$1390.
8. Awarded prizes will be delivered by mail or courier within two (2) weeks of Sponsor's confirmation of the winner. Any costs or expenses incurred by the winner in claiming or using the Prize are the responsibility of the winner. The Prize is non-transferable and no cash alternatives will be provided. The Sponsor reserves the right to substitute the Prize described above with a prize of equal or greater value.
9. By entering, all participants agree to abide by these official rules and regulations and decisions of the Sponsor which are final. All entries become the property of the Sponsor and will not be returned.
10. This Contest is subject to all applicable federal, provincial and municipal laws and regulations. Void where prohibited.
11. No correspondence will be entered into with participants except with selected winners.

Sponsor is not responsible for (a) any problems or technical malfunctions of any telephone network or line(s), computer on-line systems, servers or providers, computer equipment or software; (b) the failure of any email or entry to be received by the Sponsor due to technical problems or traffic congestion on the Internet or at any website; or (c) any combination thereof, including any injury or related damage to participants or other persons, whether computer-related or resulting from participation in, or downloading any materials in connection with, this Contest. The Sponsor reserves the right to modify, suspend and/or cancel this Contest if fraud or technical failures negatively affect the integrity of all or any part of this Contest or should a virus, bug or other cause beyond the reasonable control of the Sponsor corrupt the security or proper administration of all or any part of this Contest.
